**ENTRY FEES**

Entries will be accepted as received. **Your entry must be complete with BHA number and signed with liability waiver initialed or they will not be accepted.** Entries will be limited to 120 per judge or until the 8 hour judge limit is reached per judge per day. **Entry fees are \$15 for Instinct, \$20 for Novice/Open, \$25 for Senior/Masters**

**AWARDS**

Placement Rosettes will be awarded for 1st through 4th place in all regular classes (not Instinct) in each height division. Brown qualifying ribbons will be awarded for all qualifiers in the regular classes (not Instinct). New Title Rosettes will be awarded to those who qualify for them. Ribbons will be awarded dogs' first pass in the Instinct Test. High in Class Rosettes will also be awarded in each class.

**BITCH IN SEASON**

Bitches in season (BIS) MAY compete at Barn Hunt trials. They will be run at the end of each class. BIS must wear pants/britches at all times when not being pottied, including on the course. Owners of BIS **should crate/confine their dogs away from traffic and other dogs, should post "dog in season" signs on their crate/in their area, and potty the dog away from other competitors.** **Failure to notify the Trial Sec, Club and fellow competitors of a BIS results in a disqualification and dismissal from show grounds.** Entry fees for bitches that come into season and withdraw from the trial will be refunded, less \$5.00 admin fee.

## NOTICE TO EXHIBITORS

- Registration number and Barn Hunt Regulations may be obtained on the website, [www.barnhunt.com](http://www.barnhunt.com)
- Refunds:** Entry Fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. No entry fees will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, and act of God, public emergency, act of a public enemy, or any other causes beyond the control of the organizing committee. Refund for dog or handler injuries after close of trial may be refunded with a doctors note required.
- Bring chairs and crates for your dog. Due to limited crating space, **no flexi's, x-pens, mats and dogs not entered in trial. No crate set up prior to the trial.**
- Trials will be held indoors with air conditioning. Please make sure your crate is secure as the dogs may be highly excited. If your dog is overly excited, please do not leave him/her unattended.
- Dogs will be run in height order when possible with dogs being handled by the same person separated into different staged groups.
- Any dog of any breed or mix, six months of age or older, may participate in Barn Hunt Trials. The only limitation is that the dog must be able to fit through an 18" wide by approximately 22" high "tunnel" made of straw/hay bales.
- Height Divisions: Small, Dogs 13" & under; Medium, Dogs 13.1" to 18"; Large, Dogs over 18". Dogs are measured at the option of the judge.
- Possessing or training with personal, live quarry is not permitted on the show grounds at any time.
- The use of flexi-leads on the show grounds is not permitted during show hours.
- All dogs must be on leash at all times except when in the ring for judging. You must be mindful of other exhibitors and keep your dog close to you. Loud dogs may be asked to cover their crates or remove them from the ring area.
- Exhibitors are responsible to clean up after their dogs. **Potty areas designated by the club will be clearly marked.**
- Exhibitors are responsible for being ready to go to the staging area, in the staging area, and waiting for the call to the gate when it is their turn to run. The judge need not wait for any dog holding up a class. The club has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required.
- Owners are responsible for errors in making out entry forms, whoever may have made such errors.**
- Das Hund Haus, Inc., assume no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, spectators, or to any of their dogs, property, or children.

**From I-4 East:** Merge onto Polk Pky/SR-570-TOLL W via EXIT 41 toward Auburndale/Lakeland (Portions toll). Take the US-98 exit, EXIT 10, toward Lakeland/Bartow. Turn left onto US-98 S/Bartow Rd/SR-35 S/SR-700 S. Turn left onto Winter Lake Rd/SR-540. Turn Left on Reynolds Road - 3210 Reynolds Road is on the right after you go under the overpass

**From I-4 West:** Merge onto FL-570 E/Polk Pkwy E via EXIT 27 toward Lakeland/Winter Haven (Portions toll). Take the US-98 exit, EXIT 10, toward Bartow/Lakeland. Merge onto US Highway 98 S/US-98 E/FL-700/FL-35 toward Bartow/USF/PCC. Turn left onto Winter Lake Rd/FL-540/County Hwy-540. Turn left onto Reynolds Rd. - 3210 Reynolds Road is on the right after you go under the overpass.
