AWARDS

Placement flat ribbons will be awarded for 1st through 4th place in A classes (not Instinct) in each height division. All B classes will receive placement flat ribbons no separation of height division. Brown qualifying ribbons will be awarded for all qualifiers in the regular classes A and B (not Instinct). New Title Rosettes will be awarded to those who quality for them. Ribbons will be awarded dogs' first pass in the Instinct Test. High in Class Rosettes will also be awarded in each class in A and B divisions.

NOTICE TO EXHIBITORS

- ⊗ Registration number and Barn Hunt Regulations may be obtained on the website, www.barnhunt.com
- ⊗ **Refunds:** Entry Fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. No entry fees will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, and act of God, public emergency, act of a public enemy, or any other causes beyond the control of the organizing committee. Refund for dog or handler injuries after close of trial may be refunded with a doctor's note required.
- ⊗ Bring chairs and crates for your dog. Due to limited crating space, **no x-pens mats and dogs not entered in trial. No crate set up prior to the trial.**
- ⊗ Trials will be held outdoors in covered open side concrete floor. Please make sure your crate is secure as the dogs may be highly excited. If your dog is overly excited, please do not leave him/her unattended.
- ⊗ Dogs will be run in height order when possible with dogs being handled by the same person separated into different staged groups.
- ⊗ Any dog of any breed or mix, six months of age or older, may participate in Barn Hunt Trials. The only limitation is that the dog must be able to fit through an 18" wide by approximately 22" high "tunnel" made of straw/hay bales.
- ⊗ Height Divisions: Small, Dogs 13" & under; Medium, Dogs 13.1" to 18"; Large, Dogs over 18". Dogs are measured at the option of the judge.
- ⊗ Possessing or training with personal, live quarry is not permitted on the show grounds at any time.
- ⊗ The use of flexi-leads on the show grounds is not permitted during show hours.
- ⊗ All dogs must be on leash at all times except when in the ring for judging. You must be mindful of other exhibitors and keep your dog close to you. Loud dogs may be asked to cover their crates or remove them from the ring area.
- ⊗ Exhibitors are responsible to clean up after their dogs. **Potty areas designated by the club will be clearly marked.**
- ⊗ Exhibitors are responsible for being ready to go to the staging area, in the staging area, and waiting for the call to the gate when it is their turn to run. The judge need not wait for any dog holding up a class. The club has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required.
- ⊗ **Owners are responsible for errors in making out entry forms, whoever may have made such errors.**
- ⊗ Das Hund Haus, Inc., assume no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, spectators, or to any of their dogs, property, or children.
- ⊗ Das Hund Haus, Inc., reserves the right to refuse any entry for any reason. You will be notified by email and your entry fee will be returned.

BITCH IN SEASON

Bitches in season (BIS) MAY compete at Barn Hunt trials. They will be run at the end of each class. BIS must wear pants/britches at all times when not being pottied, including on the course. Owners of BIS **should crate/confine their dogs away from traffic and other dogs, should post "dog in season" signs on their crate/in their area, and potty the dog away from other competitors. Failure to notify the Trial Sec, Club and fellow competitors of a BIS results in a disqualification and dismissal from show grounds.** Entry fees for bitches that come into season and withdraw from the trial will be refunded, less \$5.00 admin fee.
